


# ADDISON FIRE PROTECTION DISTRICT



# Foreign Fire Tax Insurance Board Meeting Minutes January 17, 2024 (08:30am)

#### Call to order

Lt Smith called to order the regular meeting of the Foreign Fire Tax Insurance Board at 08:46 on January 17, 2024.

### Roll call

LT Smith conducted a roll call. The following members were present: Chief Kramer, BC Baxa, LT Smith, FF/PM Holdridge, FF/PM Lezza, FF/PM Gerlich.

# I. Approval of minutes from last meeting

Minutes from the December meeting were read, and the motion to approve was made by F/M Lezza, and second by FF/PM Holdridge. All were in favor, none opposed.

# II. Treasurer's Report

- a) BC Baxa submitted the budget reflecting \$261,940.98 available. However, after including pending items from the last meeting the total balanced was \$181,583.00 Lt. Smith made the motion to accept the report. FF/PM Gerlich seconded the motion. All were in favor, none opposed.
- b) Approval of accounts payable, there are none. FF/PM Lezza made a motion, LT Smith seconded. All were in favor, none opposed.

#### V. New business

- a) Lt John Sullivan requested the FFTIB to agree to the purchase of department pictures. This item was tabled by Lt Smith to include the future members getting hired in March/April, and to decide what the district needs for the stations.
- b) Lt Medernach requested the FFTIB to contribute to the purchase of a simulation manikin to aid in the training and education of the membership. FF/PM Lezza made a motion to meet the district in the middle of the remainder value after the grant of \$50,000. This was at a value not to exceed \$40,000 FFTIB. This was seconded by FF/PM Gerlich. All in favor. None opposed.
- c) FF/PM Gerlich requested the FFTIB to purchase wood pellets for the smokers for all three stations from Sam's club which has a variety blend. A motion was made by Lt Smith to purchase a pallet of these pellets annually/as needed at a cost not to exceed \$2000. This was seconded by BC Baxa. All in favor. None opposed.

a The FFTIB has given FF/PM Gorzkowski permission to move forward with quotes on maintaining or replacing the echelon spin bikes.
