Veteran's Preference Points

Applicants shall receive veteran's points as allowed by Illinois State Statue.

Fire Explorer Preference Points

Applicants who have served with the Addison Explorer Program (past or current) shall receive preference points 1 point for each year completed with a maximum of 5 points:

1 year = 1 point 2 years = 2 points 3 years = 3 points 4 years = 4 points 5 years = 5 points

Educational preference points

Applicants who have successfully obtained an associate degree in the field of fire service or emergency medical services shall receive **three (3) preference points**

Applicants who have successfully obtained a bachelor's degree from an accredited college or university shall receive **four (4) preference points**An official transcript with seal must be included with the request for preference points as proof of the attainment of degree

Paramedic preference points

Applicants who are Illinois or National Licensed Paramedics / Emergency Medical Technician Paramedic (EMT-P) shall receive **5 preference points**

Experience Preference Points

All applicants employed by the district who have been Addison Part Time Employee / Previous Contracted Employee Certified Firefighter II, certified Firefighter III, State of Illinois or nationally licensed EMT-I, licensed paramedic or any combination of those capacities shall receive one (1) preference point per each year working for the District up to five (5) maximum preference points.

1 year = 1 point 2 years = 2 points 3 years = 3 points 4 years = 4 points 5 years = 5 points

Residency Preference Points

Applicants whose principal residence is located within the district's jurisdiction shall receive **five (5) points**
