ORDINANCE NO. 2021-05

**ORDINANCE LEVYING AND ASSESSING TAXES OF
ADDISON FIRE PROTECTION DISTRICT NO. 1
DUPAGE COUNTY, ILLINOIS FOR 2021**

BE IT ORDAINED by the Board of Trustees of the Addison Fire Protection District No. 1
as follows:

SECTION ONE: That the sum of **SEVENTEEN MILLION, SIX HUNDRED AND FIFTEEN THOUSAND DOLLARS AND 00/100 (\$17,615,000)** be assessed and levied from and against all taxable property within the limits of the said Addison Fire Protection District No. 1 as the same is assessed and equalized for State and County purposes for the current year 2021 and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

CORPORATE FUND

Corporate Fund Levy \$5,500,000.00

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

AMBULANCE FUND

Ambulance Fund Levy \$5,500,000.00

The foregoing amount is hereby levied for the purpose of providing emergency ambulance service under and pursuant to the provision of 70 ILCS 705/22.

EMERGENCY AND RESCUE FUND

Emergency and Rescue Fund Levy \$ 800,000.00

The foregoing amount is hereby levied for emergency, rescue crews and equipment under and pursuant to the provisions of 70 ILCS 705/24.

AUDIT FUND

Audit Fund Levy \$35,000.00

The foregoing amount is hereby levied for audit expense purposes under and pursuant to 50 ILCS 310/9.

I.M.R.F. FUND

I.M.R.F. Fund Levy \$ 80,000.00

The foregoing amount is hereby levied for Illinois Municipal Retirement Fund contribution and withholding purposes under and pursuant to 40 ILCS 5/7-171.

SOCIAL SECURITY FUND

Social Security Fund Levy \$200,000.00

The foregoing amount is hereby levied for Social Security contribution and withholding purposes under and pursuant to 40 ILCS 5/21-110.

FIREFIGHTERS' PENSION

Firefighters' Pension Fund Levy \$4,000,000.00

The foregoing amount is hereby levied for firefighters' pension fund purposes under and pursuant to 40 ILCS 5/4-118.

Firefighters' Pension Fund Levy \$ 800,000.00

The foregoing amount is hereby levied for firefighters' pension fund purposes in accordance with PA93-0689.

TOTAL \$4,800,000.00

TORT LIABILITY FUND

Total Tort Liability Fund Levy \$700,000.00

The foregoing amount is hereby levied for tort liability purposes under and pursuant to the provisions of 745 ILCS 10/9-107

**ADDISON FIRE PROTECTION DISTRICT NO. 1
TRUTH IN TAXATION CERTIFICATION**

I, **MICHAEL J. SUPER**, hereby certify that I am the chief presiding officer and President of the Addison Fire Protection District No. 1, DuPage County, Illinois, and as such, I hereby certify that the District's 2021 tax levy ordinance, a copy of which is attached hereto, was adopted pursuant to, and in all respects in compliance with, the provisions of Sections 18-60 through 18-85 of the Truth in Taxation Law, 35 ILCS 200/18-60 through 18-85.

The District levied an amount that is greater than 105% of the final aggregate extension plus any amount abated prior to extension for the 2020 tax levy, therefore the publication and hearing provisions of the Truth in Taxation Law are applicable and have been met. The District held a public hearing on its 2021 tax levy on December 1st, 2021.
