**ORDINANCE NO. 2022-02**  
**ORDINANCE PROVIDING FOR THE BUDGET AND APPROPRIATIONS OF THE**  
**ADDISON FIRE PROTECTION DISTRICT #1, DUPAGE COUNTY, ILLINOIS**  
**FOR THE FISCAL YEAR BEGINNING JUNE 1, 2022 AND ENDING MAY 31, 2023**

WHEREAS, there has been prepared in tentative form a budget and appropriations ordinance for Addison Fire Protection District No. 1 of DuPage County, Illinois, and the Secretary of said fire protection district has made a tentative budget and appropriations ordinance conveniently available for public inspection for at least thirty (30) days prior to final action thereupon; and

WHEREAS, a public hearing was held as to such budget and appropriations ordinance on August 3, 2022 at 9:00am Central Savings Time, notice of which was given at least thirty (30) days prior thereto by publication in a newspaper published in the Addison Fire Protection District, and having complied with all other legal requirements.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Addison Fire Protection District No. 1, DuPage County, Illinois, as follows:

SECTION 1. That the fiscal year for this Fire Protection District be and the same is hereby fixed and declared to be from the 1<sup>st</sup> day of June 2022 to the 31<sup>st</sup> day of May 2023.

SECTION 2. A more detailed working budget is on file with the District and available for inspection.

SECTION 3. That the following Budget containing an estimate of the revenues available and expenditures and the appropriations contained therein be and the same is hereby adopted as the Budget and Appropriations of the Addison Fire Protection District No. 1 for the fiscal year beginning June 1, 2022 and ending May 31, 2023; and the following sums of money, or as much thereof as may be authorized by law, are hereby appropriated to defray the necessary expenses and liabilities of the Addison Fire Protection District No. 1 for the respective objects and purposes, as hereinafter set forth, namely:
