The scope of work includes replacement of the front concrete apron and parking areas, curb modifications, asphalt paving, installation of a handicap-accessible ramp, relocation of the existing flagpole, and installation of electrical service for future LED sign and site improvements.

Project Overview and Scope of Work

- The work shall include, but is not limited to, the following:
- Removal and replacement of the existing concrete apron and front parking area.
- Removal of the concrete curb island parallel to Vista Avenue.
- Removal and expansion of the concrete curb peninsula extending east from the front of the station.
- Asphalt paving of the parking area currently constructed of concrete.
- Installation of a handicap-accessible concrete ramp from the parking area to the main entrance.
- Removal of the existing flagpole and installation of a new flagpole at a designated location on the peninsula.
- Installation of electrical service to accommodate a future LED sign and flagpole lighting.

The selected contractor will be responsible for providing all labor, materials, equipment, warranties, construction, and installation services necessary to complete the project in accordance with the District's specifications.
